

Declaration of conformity and CE mark

Where our products come under the area of application of an EU directive, we produce a declaration of conformity and confirm compliance with said declaration of conformity.

- MRL / NRL: The products receive a CE mark if required by the directive.
- RoHS: The products receive a CE mark on request.

Machine directive 2006/42/EC (MRL)

Products of the Ortlinghaus standard series are components. They do not fall under the area of application of the machinery directive because although they are intended for installation in machines they are not designed for a specific application (for a special type of machine).

Customer-specific products have a specific configuration as per the connection and performance data. These modified products are based on the standard series, however, and are likewise components.

For this reason, a declaration of conformity or installation is not produced for these products.

Naturally, the products satisfy all applicable legal requirements, particularly with regard to further relevant regulations concerning CE marking and the product safety laws in Germany and Switzerland (ProdSG, PrSG).

Low voltage directive 2014/35/EU (NRL)

Electronic, electromagnetic and electrohydraulic products from Ortlinghaus may fall under this EU directive if the voltage is >50VAC and >75VDC and another specific directive does not exclude this NRL. RoHS directive 2011/65/EU (formerly 2002/95/EC)

Electronic, electromagnetic and electrohydraulic products and also products with integrated electronic components from Ortlinghaus may fall under this EU directive if they are not installed in large-scale, fixed installations.

Other products, e.g. hydraulic and pneumatic products, are not subject to this EU directive, i.e. we are not permitted to product a declaration of conformity. However, should you require confirmation that a product of this kind is within the substance limits of this EU directive, we are able to provide this confirmation for certain order and material numbers.

SCIP database

The SCIP duty to inform applies to all items that are circulated in the EU.

Ortlinghaus-Werke GmbH (Wermelskirchen, Germany) will carry out all registrations and inform you of this. Ortlinghaus Gams GmbH (Gams, Switzerland) will provide you with the necessary information for registration in the SCIP database. Registration in the database is to be carried out by you as an EU importer. This information contains the product, component and affected substance from the SVHC substance list. If SCIP numbers are partially present from the supply chain, we will inform you of these as well. You can glean the instruction from the operating instructions and/or order documents.
